Terms of Reference (ToR- Annexure-1)

Background:

"Enhancing Climate Resilience of India's Coastal Communities" (ECRICC) project, initiated in 2019, aims to safeguard vulnerable coastal populations by enhancing ecosystem resilience and diversifying livelihoods. Implemented across 3 coastal states (Adhra Pradesh, Maharashtra and Odisha) of India, the project employs an ecosystem-based adaptation (EbA) approach and is supported by the Green Climate Fund (GCF), Ministry of Environment, Forest and Climate Change of India (MoFECC) the Forest, Environment and Climate Change (FE&CC) Department Government of Odisha, and the United Nations Development Programme (UNDP). In Odisha the project is implemented in 7 landscapes of 4 coastal districts (Balasore, Puri, Kendrapada & Ganjam). Under this project, ECRICC goes beyond climate action—it empowers the heart of coastal communities. Recognising their potential as agents of change, the project equips them with climate-smart skills in sustainable aquaculture and agriculture, enabling them to support their families and lead community resilience efforts. With local communities, government bodies, and international organizations working together, ECRICC in Odisha is taking bold steps to protect its coastal ecosystems and build a sustainable future for all. Through the ECRICC project, restoring mangroves, coastal watersheds, seagrass meadows and salt marshes isn't just conservation, it's a powerful solution for climate resilience, food security, and thriving coastal communities.

Objectives of the assignment:

- 1. Capacity Building: Equip local communities with knowledge and skills to monitor key indicators of coastal ecology, ensuring alignment with environmental sustainability principles.
- 2. Community Participation & Safeguards: Foster inclusive and equitable participation of all community members, including marginalized groups, in compliance with the Environment and Social Management Framework (ESMF) provisions.
- 3. Sustainability & Safeguard Compliance: Develop community-led monitoring systems that adhere to ESMF guidelines, ensuring no harm to ecological balance or social cohesion.

Scope of Work:

The selected Organization will undertake the following tasks:

1. Needs Assessment:

- Conduct baseline assessments of community awareness, skills, and current ecological practices.
- Identify key ecological parameters relevant to project sites.
- Screen potential environmental and social risks associated with training and community monitoring in line with ESMF requirements.



- Training Module Development: Design bilingual (Odia & English) e-learning module/ training manuals integrating:
 - Coastal ecology basics (mangroves, seagrass, saltmarshes, watershed, biodiversity, water quality, etc.)
 - Participatory monitoring techniques.
 - Principles of environmental safeguards, sustainable resource use, and climate resilience.
 - Social safeguards: gender equity, social inclusion, respect for indigenous knowledge, grievance redress mechanisms.

3. Monitoring Toolkit:

- Develop cost-effective, environmentally safe, and user-friendly monitoring toolkits.
- Include guidance on responsible data collection, avoiding disturbance to sensitive habitats.
- 4. Community-Led Monitoring Plan: Facilitate development of monitoring plans ensuring:
 - Free, prior, and informed consent (FPIC) of community members.
 - Consideration of potential environmental and social impacts of monitoring activities.
 - Inclusion of grievance redress mechanisms in line with UNDP's ESMF.

5. Capacity Strengthening of Local Institutions & project staff:

- Strengthen capacities of panchayats, eco-development committees, VSS members, WSHG
 Federations and NGOs, project staff, emphasizing compliance with environmental and
 social safeguards.
- **6. Training Implementation:** Conduct community workshops and field-based trainings in adherence to Environment and Social Management Framework (ESMF) standards:
 - Ensure gender-sensitive, socially inclusive approaches.
 - Avoid exacerbating any community conflicts or resource-based disputes.
 - Comply with local health and safety regulations.

7. Reporting: Provide detailed reports including:

- Pre- and post-training assessments.
- Documentation of community participation disaggregated by gender, caste, and vulnerable groups.
- Summary of environmental and social risks mitigated.
- Recommendations for safeguard compliance in future community-based activities.

8. Deliverables:

- vii. Final synthesis report including ESMF compliance summary & recommendations
 - 9. Duration of this Assignment: 6 months from the date of signing the contract.
 - 10. Qualifications of the Proposed Expert Organization:

The Organization must be registered in India under Society Registration Act 1860 /Companies Act 1956 /Trust Act 1882/ Charitable Trust /CSR Foundation established by the corporates etc with appropriate act of the country having minimum of 5 years registration under any act as mentioned above. The applicant organization should not have been blacklisted by any GoI/GoO/ Any other state government organization/agency/department or any reputed international organization in the past before the date of the application.

- 11. Experience of the proposed Expert Organization:
 - The Organization must have **5 years prior experience** on inclusive capacity building programs for coastal communities, Community Resource Persons, development professionals on issues related to climate change, conservation and restoration of coastal ecosystem and its monitoring in India.
 - The Organization must have worked with local NGOs / CSOs/ VSS/EDCs. WSHG Federations etc for at least One Year in Odisha
 - The Organization must have trained and technical pool of resource persons including expert professionals/ resource persons for developing training modules, participatory planning and monitoring tools on coastal ecology and conservation measures.
- 12. Demonstrated experience in applying environmental and social safeguards, preferably within UNDP or similar frameworks.
- 13. Language Fluency of the Resource Persons to be deployed by the selected organization must be in Odia.
- 14. The Organization must have prior experience of working with the Govt. of Odisha and/or national government and/ or reputed international organizations.
- 15. The Organization must have demonstrated experience in applying environmental and social safeguards, preferably within UNDP or similar international frameworks.
- 16. Environmental and Social Safeguards Compliance: Regular consultations with community stakeholders, ECRICC SPMU and DPMUs, and relevant government bodies will be undertaken to ensure safeguard compliance. All activities must be in strict alignment with UNDP's Environmental and Social Management Framework (ESMF), ensuring:
 - Do No Harm Principle
 - Gender Equality and Social Inclusion
 - Free, Prior, and Informed Consent (FPIC)
 - Grievance Redress Mechanisms
 - Environmental Sustainability and Protection of Critical Habitats
- 17. Coordination & Reporting: The selected Organization will depute a representative to the SPMU, ECRICC, Odisha who will work under the supervision of the State Project Manager, State Project Management Unit (SPMU), Odisha, closely working with the project DPMUs, Facilitating NGOs and relevant government departments. SPMU-ECRICC may organize relevant workshop at state level with technical support of the organization.
- 18. Budget: To be proposed by the interested Organization, including all costs for logistics including travel, food, accommodation, material development, module development, training, professional fees, printing, other stationaries etc. Applicable GST & Other taxes would be deducted during payment of consultancy fee as per prevailing tax law of Odisha & India.



- 19. Cost of Training at State & Landscape Level: ECRICC project would meet additional cost of training of 30 participants at State level and 210 participants at project landscape level in 7 project landscapes of 4 project districts towards cost of venue charges, food, teaching materials, banner, contingency etc. and this budget would be managed by the DPMUs & SPMU-ECRICC, Odisha. The selected Organization is expected to provide technical support as Resource Organization to facilitate these training programs at State & project landscapes level. If needed, ECRICC would organize state level workshop and the selected organization would provide technical support during the workshop.
- 20. All materials and modules developed by the selected Organization shall be the property of ECRICC Project, Odisha and the consultant/organization shall not share it to any individual/organization directly or indirectly without permission of SPMU, ECRICC Project, Odisha.
- 21. All disputes related to this assignment shall be limited to Bhubaneswar, Odisha jurisdiction only.

Top scored shortlisted Organizations would be communicated for further discussion/negotiation on the financial proposal. Award of this assignment would be given to the applicant Organization having highest technical score and negotiated budget is within the budget for this assignment. In case of highest scored Organizations does not want to take up the assignment, next highest scored Organization would be invited for financial negotiation and so on. SPMU, ECRICC, Odisha would constitute a committee for evaluation of shortlisted proposals and



- ecommend for selection of the organization. The Consultant organization would be released contract value/ consultancy fees by SPMU, ECRICC after submission/completion of deliverables as per time lines mentioned above.
