Terms of Reference (ToR- Annexure-1)

1. Background:

"Enhancing Climate Resilience of India's Coastal Communities" (ECRICC) project, initiated in 2019, aims to safeguard vulnerable coastal populations by enhancing ecosystem resilience and diversifying livelihoods. Implemented across 3 coastal states (Adhra Pradesh, Maharashtra and Odisha) of India, the project employs an ecosystem-based adaptation (EbA) approach and is supported by the Green Climate Fund (GCF), Ministry of Environment, Forest and Climate Change of India (MoFECC) the Forest, Environment and Climate Change (FE&CC) Department Government of Odisha, and the United Nations Development Programme (UNDP). In Odisha the project is implemented in 7 landscapes of 4 coastal districts (Talsari landscape of Balasore district, Devi Mouth & Chilika-Puri landscapes of Puri district, Bhitarkanika & Mahanadi Mouth landscapes of Kendrapada district, & Bahuda and Chilika-Ganjam landscapes of Ganjam district). The project has three main outputs to achieve as follows:

Output-1: Enhanced Resilience of Coastal and Marine Ecosystems and their Services (Mangroves, Seagrass, Salt Marshes & Watersheds)

Output-2: Climate-adaptive livelihoods for enhanced resilience of vulnerable coastal communities.

Output-3: Strengthened governance and institutional framework for climate-resilient management of coastal areas.

2. Project Implementation Modalities

The project is being implemented in 13 blocks of 4 coastal districts of Odisha (Balasore, Kendrapada, Puri and Ganjam) under the overall day to day supervision of the State Project Director-ECRICC, Odisha, SPMU, Bhubaneswar. Divisional Forest Officers of Berhampur, Rajangar, Puri & Balasore are designated as Nodal Officers of ECRICC in respective project districts and working under the leadership of District Collector of respective district who is the Chairman of the District Level Coordination Committee (DLCC) of the project notified by Govt. of Odisha. To assist the Nodal-Officers of ECRICC Project, District Project Management Units (DPMUs) of ECRICC Project are functioning housed at respective office of Divisional Forest Officers. Facilitating NGOs and Climate Champions have been engaged in each project landscape to assist DPMU for implementation of the project at landscape level.



3. Chilika Development Authority (CDA) to act as the Nodal Agency for Implementation of Seaweed Farming & Market Linkage with the assistance of the TSA-Seaweed closely working with the DPMUs-ECRICC (Puri & Ganjam).

The seaweed farming and market linkage activity would be implemented by the Chilika Development Authority under the overall monitoring of the interventions by SPMU-ECRICC, Odisha and assistance of technical support of the Technical Support Agency (TSA) to be engaged under ECRICC for the pilot demonstration phase. CDA would closely work with the DPMU-ECRICC (Ganjam) & DPMU-ECRICC (Puri) for mobilization of the farmers, training & capacity building of project staff and farmers, implementation of the interventions etc. CDA would also give necessary clearance for promotion of seaweed farming in the Chilika Lagoon. SPMU would release fund to the CDA (except cost of the TSA) as per approved AWP of 2025 . All procurement of materials, seeds, equipments etc. would be done by the CDA following relevant guidelines of GoO.

4. Promotion of Seaweed Farming with Farmers and Market Linkage at higher Supply Chain under ECRICC and requirement of support of a Technical Support Agency (TSA) for Pilot demonstration and market linkage.

Under Climate Adaptive Livelihoods Activities (Output-2) of the project, Seaweed farming and its market linkage has been budgeted under the project for diversification of income of the project beneficiaries with a target to cover 338 households by closure of the project. To achieve this objective and target, State Project Management Unit (SPMU) of ECRICC, Odisha is planning to engage one Technical Support Agency (TSA) for initial demonstration of seaweed farming with 70 Nos.of farmers /Beneficiaries in the appropriate feasible sites of Chilika Lagoon covering Chilika -Puri, Chilika-Ganjam & Bahuda project landscapes of Puri & Ganjam project districts. The TSA – Seaweed farming is expected to deliver the following task for SPMU, ECRICC while working with other relevant project stake holders (Chilika Development Authority -CDA, DFO(WL)-Chilika, DFO(T)- Berhampur (DPMU-Ganjam) & DFO (WL)-Puri (DPMU-Puri). Taking learning and experience from the TSA during Pilot demonstration of seaweed farming with 70 Nos of Farmers/Beneficiaries & market linkage of seaweed products, project teams would scale up these interventions to targeted number of beneficiaries by closure of the project. DPMUs (Puri & Ganjam) and assigned FNGOs of respective project landscapes would provide necessary support to the TSA during implementation of pilot demonstration of seed weed farming and its market linkage.

5. Key Deliverables for the proposed Technical Support Agency (TSA- Seaweed Farming)

- (a) Submission of Inception Report, Detailed Project Report and facilitate project inception workshop. (workshop will be organized by SPMU, ECRICC Odisha).
- (b) Identification of technically feasible suitable sites for seaweed farming and mobilization of beneficiaries closely working with respective DPMUs/FNGOs, selection of beneficiaries for demonstration with 70 Nos of farmers.
- (c) Technical Training & Capacity Building of 70 Beneficiaries & 50 Project staff (DPMU, FNGOs & Climate Champions). Training logistics to be arranged by DPMUs.
- (d) Facilitate Seaweed Seed Collection from Odisha and/or other States and provide technical & handholding support to project teams and beneficiaries for seaweed production/demonstration with 70 Nos of beneficiaries (At least 3 Cycles of Production with minimum of 2 Rafts per beneficiary and upscaling to 6 rafts per beneficiary by 3rd cycle of production)
- (e) Facilitate forward market linkage of seaweed production of farmers with higher supply chain /entrepreneurs/industrialists engaged in seaweed processing and value addition to offer remunerative price to the seaweed farmers/producers.



- (f) Develop & Capture baseline of seaweed farmers closely working with DPMUs, Develop Training Modules, Process Document & IEC materials for the entire cycles of sea-weed production (in English & Odiya) and submission of soft copies along with one set of the hard copy of the same & 5 Nos of stories successful farmers and best practices in soft copies to SPMU, ECRICC, Odisha.
- (g) Facilitate Learning and closure Workshop, to be organized by SPMU & Submission of Project Completion Report to SPMU, ECRICC, Odisha
- 6. Duration of this Consulting Assignment for the TSA: Initially for a period of 12 months (One Year) from the date of signing of the contract and the contract may be renewed as per requirement of SPMU during upscaling phase subject to satisfactory performance of the selected organization and availability of budget under ECRICC
- 7. Qualifications of the proposed TSA Organization: The Organization must be registered in India under Partnership Act 1932 / Limited Liability Partnership (LLP) Act 2008 / Society Registration Act 1860 /Companies Act 1956 /Trust Act 1882 etc. with a minimum of 3 years registration under any act as mentioned above. The applicant organization should not have been blacklisted by any Gol/GoO organization/agency/department or any reputed international organization in the past before the date of the application.
- 8. Experience of the proposed TSA Organization:
 - The Organization must have prior experience in Odisha on implementation of seaweed farming with relevant technical knowledge and expertise on seaweed farming.
 - The Organization must have network with market linkage players for forward linkage of seaweed production/processing.
 - The Organization must have trained and technical manpower/professionals/ resource persons on implementation of seaweed farming.
 - The Organization must have worked with the communities at grassroot level.
 - Demonstrated experience in applying environmental and social safeguards, preferably within UNDP or similar frameworks.
 - Experience in conducting inclusive capacity-building programs in Odisha or similar socio-ecological contexts.
 - Prior experience of working with the state and/or national government and/or reputed international organizations and/or reputed research institute.
 - Fluency in Odia is desirable.
- 9. **Environmental and Social Safeguards Compliance:** Regular consultations with community stakeholders, ECRICC SPMU and DPMUs, and relevant government bodies will be undertaken to ensure safeguard compliance. All activities must be in strict alignment with UNDP's Environmental and Social Management Framework (ESMF), ensuring:
 - Do No Harm Principle
 - Gender Equality and Social Inclusion
 - Free, Prior, and Informed Consent (FPIC)
 - · Grievance Redress Mechanisms
 - Environmental Sustainability and Protection of Critical Habitats
- 10. Coordination & Reporting: The Organization will depute One of Officer as the contact person for this consulting assignment who will work under the supervision of the State Project Manager, State Project Management Unit (SPMU), Odisha, and designated Officer of the Chilika Development Authority (CDA) closely working with DPMUs (Puri & Ganjam), Facilitating NGOs, relevant government departments and Communities.
- 11. **Budget:** To be proposed by the Organization, including all costs of travel, professional / consulting fees, stationaries, contingency, honorarium of professionals / Field workers, fees of



resource persons etc. Applicable GST & Other taxes would be deducted during payment of consultancy fee as per prevailing law of Odisha & India.

- 12. Cost of Training at Landscape, DPMU & State Level: ECRICC project would meet the cost of training of 70 Nos of Beneficiaries at landscape level and 50 Nos of project team members at project landscape and DPMU level. The TSA is expected to provide technical support as Resource Organization to facilitate these training programs inviting resource persons. The cost of Inception & Closure Workshops to be met out of available fund at SPMU.
- 13. All materials and modules developed by the TSA-Seaweed shall be the property of ECRICC Project, Odisha and the consultant shall not share it to any individual/organization directly or indirectly without permission of SPMU, ECRICC Project, Odisha.
- 14. All disputes related to this assignment shall be limited to Bhubaneswar, Odisha jurisdiction only.
